

# GARY REPORT

## Intercession/Identification

Upon completing the last "Gary Report" and preparing to post it, I received a phone call from Caleb. He advised me that Lawrance had begun his drive in the Bride car from Bungoma where it had been in service at the hospital there as a source of income, and was on his way to where Caleb and the other Bride brothers were; but, he was no longer responding to phone calls. This greatly troubled the doctor at the hospital, as well as Caleb, and was very foreboding. Carrying with him in cash was their payment for the last month of service, which was \$1,100 and would be provision for their journeys as I described in the last Report. This was VERY disturbing to me. Just now on the other side of all of the loss of life and damages from those out of Busia in the dreadful month of April, which was turned into victory in May, it was greatly troubling that there could be loss again when we were expecting victory.

In this situation there were three points of prayer and concern. First was the great concern that Lawrance was murdered. Again, how could we have death ruling on this side of April? Second, that car was vital for their plans to split into two groups, making that now impossible! And third, the \$1,100 in funds would be eliminated, which they were counting on. Again, how could Satan get the victory when we were on the other side of April? When I found out about this, it was very troubling; and I had just finished writing the last Report and was preparing to send it out. Thus, everything was put on hold at that point.

My heart went before the Father, and with the looming disappointment I asked one thing of Him. Theoretically, a car could be replaced, and money lost could be overcome, but the loss of Lawrance's life to death would be a great blow and could not be replaced. So I asked the Father: Please allow for Lawrance to remain alive. With this looming situation, the entirety of that day was extremely heavy! The next day, I awoke with the following email from the doctor with whom Caleb worked at the hospital:

Caleb and Gary,  
LAWRANCE WAS FOUND IN THE HOSPITAL WITH CUTS ALL OVER HIS BODY,  
FINGERS, HEAD; BUT HE IS STILL ALIVE. PLEASE GIVE ME A CALL. AND CALEB  
NEEDS TO COME AND CARRY THE LOGBOOK SO THAT WE CAN REPORT THE CAR  
CASE TO THE POLICE.

Lawrance had been attacked with machetes and was placed in Intensive Care, hanging onto life from loss of so much blood. But praise Yahweh he survived the attack and is now out of ICU. I was greatly relieved, and grateful that the Father had answered that prayer. But then there was the next step—the car that is so valuable to us. So I went further and asked the Father to restore the car as well. And the next day I got a call from Caleb. The car had been driven though the Uganda border at Busia and over to the Rwanda border. But the Rwanda border is not an open border like Uganda's and

the driver had to prove that he was the owner of the car. To try to avoid being caught, he fled on foot and was shot and killed, and the other man in the car was taken into custody. The car was registered in Caleb's name and the authorities contacted him and notified him that he needed to come and bring proof of identification to claim it. Praise Yahweh! And gratefully, we had the \$400 for him to travel there (because of high fuel costs in Africa, transportation is expensive).

Of course Busia has been the source of all of the killings and troubles pertaining to the Bride. The two men did not have the money on them when they were caught, and it was undoubtedly dropped off at Busia and they then took the car as their booty. But, there is now one man in custody and he is talking. Already, seven men in Busia have been identified in this plot. Hopefully the root of this jealousy can once again be dealt with. The plan is to move the man in custody to Busia, and Constable Rubben will now travel there and handle this case as he did so with the others, once again insuring that justice is accomplished. And one thing for certain though, the god of this world who has had the power of death for two and even six thousand years, must come to an end as well! That is what all of this comes down to anyway.

The title of this Report is "Intercession/Identification." And truly, this entire matter evidences to be a shadow of that which is taking place in the heavenly, in the spiritual. It looked like death and loss would rule, but instead we have been given victory. I asked the Father for good for two out of three situations, and very gratefully received both. And I pray as well that the previous two parts of the church will be restored from Satan in like manner. That is where we are in this life, and Satan needs to be exposed and come to an end in his troubling and death. And, this is why I want to see the perpetrators of this recent crime brought to swift justice. Because all the more I want to see Satan come to a swift end and victory secured and men's blinded eyes opened, as we are seeing take place all across Africa.

We look forward to Lawrance's recovery, and are most grateful for him being delivered from him who has possessed the power of death. And we are thankful for that car being found. But, the spare tire and rim were stolen, and another rim was damaged, and the two rear tires have to be replaced. And one of the things I learned while in Africa is that you don't buy cheap tires—they don't last—and the imports are expensive. The cost of these items just to get the car back into use is \$1,200. And it will cost \$250 in fuel for Caleb to make his return trip. And it will cost \$300 to get Rubben to Busia so he can file legal papers against the seven remaining men in Busia and bring them to justice as well. These expenses alone are easily approaching \$2,000. And we have no idea what the cost will be from Lawrance's stay in ICU and thereafter in a regular room/bed. And there are more travel expenses coming. We could easily see another thousand dollars before this is all over, totaling \$3,000.

Let me tell you, Satan does not fear the Body of Christ. He has been corrupting and taking to death the Body of Christ for two thousand years. But the one work he does fear is the Bride, the sun-clothed woman of Revelation 12 who can birth the Man Child back to this earth, and has the authority to bind him in chains and throw him into the Abyss! This is the battle we presently have in Africa. In Africa where the Bride message has gone forth across that entire continent and beyond, only in Kenya, the home of the Bride—and more specifically in Busia, which from the outset attested to

violence as three bishops tried to forcibly stop the meeting—is Satan taking a stand to destroy the Bride work. And remember, I myself almost did not go to that first meeting, having stepped off the road in the cover of darkness two nights before and severely damaged my right foot and ankle.

From the beginning, this work in and from Busia has been a battle with Satan. And if you want to see Satan destroyed, then I ask you to give. I myself am on social security. That is my only source of income. I take nothing from the Bride account. The entirety of your gifts go to the Bride work. But given the clear significance of these events and the great need, I will reach into my account and give \$1,000 (my income for one month—in fact, upon talking with Caleb, of necessity I just deposited it in the Bride account). I want to see Satan lose, and this is one way I can intercessorally do something about it. I stepped forward before the first meeting in Busia and it cost me a lame foot, and I will step forward again now and give. Will you join me and step forward as well? If you don't, I will fail without you. I/we need your help. I have given the one-third portion, and hopefully you will give the two-thirds. Satan needs to fall, the one whose image is clearly set forth on that cursed continent. Give as though you are striking a blow against Satan himself. And remember, the Jael Bride is the one who has to do it. Christianity has failed, and will continue to fail! But we need victory! Will you match my gift, or give an amount that will indeed make a difference, or even give the smallest amount? Will you strike a blow against Satan, as if you were fighting for your own life and for your family?
